

BOOKING & PACKAGING MINIMUM REQUIREMENTS FRESH/FROZEN & LIVE SEAFOOD

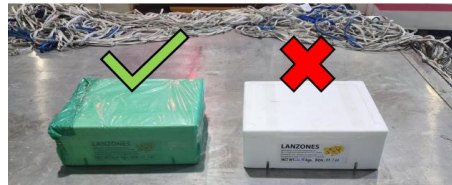
The following is applicable only for loose bulk shipments.

OUTER PACKAGING	<ol style="list-style-type: none"> Heavy duty fiberboard/cardboard carton or boxes <ul style="list-style-type: none"> Carton/box must be leak -proof in all positions. The upper and lower seams of the carton/box must be securely fastened with 5cm wide adhesive tape. Each carton/box is to be banded with a minimum of two bands around the width of the carton/box Waxed Fiberboard Cartons or Boxes <ul style="list-style-type: none"> Same as above High Density Styrofoam Boxes <ul style="list-style-type: none"> If (3) is used, the above requirements + (A) or (B) (A) The box must then be placed in a polythene bag (minimum thickness of 3 mm) and the lid of the box must be securely with 5 cm wide adhesive tape completely around the box at both ends and around the seam. Customers are responsible for using a polythene bag for the outer package (B) Pack them in a multi-walled, wax impregnated fiberboard outer container or box with leak-proof corners or leak-proof plastic or fiberglass containers. These must not exceed the manufacturer's maximum capacity 	<ul style="list-style-type: none"> Packaging with wet ice Banding must not be used on Styrofoam boxes as it can cut into the boxes thereby compromising its structural identity
INNER PACKAGING	<ul style="list-style-type: none"> The product must be completely enclosed in a sealed polythene bag that has a minimum thickness of 0.2 mm Air remaining in the bag should be let out after the fish/seafood has been put in. The top of polythene bag must then be gathered, twisted, folded over and sealed with an elastic band. Protective liner pads of cardboard, Styrofoam or crumpled newspaper

OUTER PACKAGING	<ul style="list-style-type: none"> Leak-proof containers and have secured lids Packaging with gel packs The container may be banded with a minimum of two plastic bands, or two strings, or two bands of tape around the width of each box 	<ul style="list-style-type: none"> Packaging with wet ice Snap lids or Styrofoam used as the outer box for Live Seafood is not permitted
INNER PACKAGING	<ul style="list-style-type: none"> Styrofoam is accepted for inner packaging Containers must also be lined with a leak proof membrane to prevent leakage from damaged containers
